

HAPPY WONDERLAND BUDAPEST - HOUSE RULES



DEAR VISITOR,

These House Rules contain the mandatory entry and conduct regulations applicable to the event "Happy Wonderland" (the Event), organized and operated by Dankeschön Kft. (registered address: 1118 Budapest, Ratkóc utca 15., tax number: 26532970-2-43; the Organizer).

Event venue: 1146 Budapest, Olof Palme sétány 5.

Event dates: 21 November 2024 – 05 January 2025

I. PARTICIPATION IN THE EVENT

- 1 Entry to the Event is free of charge. Visitors under the age of sixteen may only stay on the Event premises under the supervision of an adult.
- 2 Visitors fill the Event area in the order of arrival. This does not apply to designated organizer-only areas, which may only be accessed with proper accreditation.
- 3 For the safe and secure operation of the Event, the Organizer reserves the right to restrict items and equipment that may be brought onto the premises. It is strictly prohibited to bring any of the following into the Event area:
 - narcotics,
 - pyrotechnic devices,
 - glass objects,
 - objects containing explosive, toxic or flammable materials,
 - firearms,
 - knives with a blade longer than 8 cm, butterfly knives, switchblades,
 - pepper spray,
 - weighted batons, expandable batons,
 - metal chains longer than 50 cm,
 - throwing stars, slingshots,
 - and any other objects considered particularly dangerous under relevant legislation (currently Government Decree 175/2003 (X.28)).
- 4 Drones are strictly prohibited. Visitors carrying any of the restricted items may not enter the Event area. The Organizer is entitled to conduct random checks (including inspection of bags and clothing), which visitors must submit to. Those who refuse inspection or violate the prohibition may be removed from the Event.
- 5 Apart from assistance dogs, guide dogs and police dogs as defined by law, only pets that are generally considered docile, non-dangerous, and can be kept on a leash may enter the Event area. However, bringing pets is not recommended, and the Organizer suggests leaving them at home.



Pets may only be allowed in if all of the following conditions are met:

- valid vaccination record with rabies vaccination not older than 1 year,
- unique identification (readable tattoo or microchip),
- leash, collar, muzzle, and a tag including the owner's contact number available during the Event.

6 The Organizer reserves the right to prohibit the entry of any individual animal and to continuously check compliance. Animals not meeting the requirements may be removed for safety reasons.

II. CONDUCT REGULATIONS

1 Visitors must behave in accordance with general social norms, relevant legislation, and these House Rules. They must refrain from any conduct that may endanger or violate the rights, health, or physical integrity of others. Visitors are requested to dispose of waste in the designated bins.

2 The Visitor acknowledges that audio and visual recordings may be made at the Event by the Organizer, accredited press, third parties authorized by the Organizer, and by other visitors.

By participating in the Event, the Visitor expressly consents to the recording and use of their image, likeness, or statements. Naming the Visitor requires explicit consent, except where the Visitor qualifies as a public figure.

The creators of such recordings obtain unrestricted, transferable, exclusive usage rights—without time, territory, or method limitations—and may use, reuse, publish, adapt, broadcast, and distribute the recordings without compensation to the Visitor. Visitors may also take photos and videos for personal use only, using mobile devices or non-professional equipment. They may not sell, commercially use, or publish recordings without the consent of the individuals appearing on them, and must respect personality rights. The Organizer excludes all liability for violations committed by other visitors.

3 Any economic, commercial, or advertising activity on the Event premises—including the entrance area—is prohibited without prior written authorization from the Organizer.

4 Minors (under 18) and intoxicated persons may not be served alcoholic beverages at the Event's commercial or hospitality units. The consumption of substances classified as narcotics is prohibited by law and also forbidden on the Event premises.

5 As the purpose of the Event is to provide a cultured and undisturbed entertainment experience, any form of demonstration—regardless of participant numbers—is strictly prohibited.



6 By participating, the Visitor agrees to cooperate fully with the Organizer and the Event staff within legal limits and to follow all instructions in case of emergency.

III. OTHER PROVISIONS

1 The Organizer is liable only for intentional breaches attributable to it, and for violations that cause harm to human life, physical integrity, or health. Beyond the rights granted to Visitors by law, the Organizer expressly excludes liability for all other types of damage.

2 The Organizer assumes no responsibility for valuables or personal belongings brought into the Event.

3 The Event may take place even in bad weather.
The Event will not be held if force majeure circumstances make it impossible.
The Event may be interrupted or closed if required by authorities or due to force majeure. In such cases, Visitors must leave the area following the Organizer's instructions.

4 The Organizer recommends that Visitors avoid approaching the Event by car where possible, and that they pay special attention to their own safety, the safety of others, and their personal belongings while on site.
